All entries, accommodation reservations, transport needs, flight arrival/departure information and visa invitation letter requests are to be completed using the World Archery Online Registration System WAREOS <u>https://extranet.worldarchery.sport</u>. This system handles the entire registration process for this event. **No** entry forms, hotel reservations or transportation forms will be accepted; all information must be entered into WAREOS.

Member associations can login to WAREOS at <u>https://extranet.worldarchery.sport</u> with the username and password assigned by World Archery. After entering WAREOS, selecting the event from the list will allow a member association to register their athletes. Select/press the "Entries" button to see the list of categories in the event. Select/press the "category" to enter the athlete and official numbers/details participating for that event. A WAREOS User Manual can be downloaded in PDF format (English) upon login.

A maximum of **three (3) athletes per country** (the host country included) are allowed to be registered in each category of the event. Preliminary entries must be completed using WAREOS.

Member Associations can only use WAREOS to make any changes/amendments to their entries and will be able to do so at any time. An email will be automatically sent to the Organizing Committee and Member Association with the updated information in WAREOS.

There is no entry fee for teams.

Entry fees include daily local transport to and from the practice field to/from official hotels during the qualification, elimination, and finals venues (the transportation timetable will be confirmed on-site).

All other fees applicable to the event can be found in the <u>Policies and Procedures Athletes</u>, <u>Officials and</u> <u>Team Management</u>.

Member Associations that have penalty fees outstanding from 2023 will need to have paid these penalty fees before being eligible to enter and compete.

Any entries received less than 3 days before the team managers meeting for a World Championships will be refused if no preliminary entry and/or final entry is made prior. This decision cannot be appealed by the teams and is fully compliant with the current World Archery rules, article 3.7.1.2.

Entries received after the deadlines, are subject to penalties as clearly stated in the rule book and the invitation documents of World Championships. A Member Association that has made final entries in WAREOS and does not participate will be invoiced for the number of entries entered in the system unless they have informed World Archery and the Organising Committee in writing at least one week prior to the event that they are unable to attend.

*VIP ACCESS – Must be approved by LOC before credentials are issued. Examples of VIP's include Presidents of Federations, Secretary General, World Archery Officers, etc. VIP credentials provide access to the VIP area at the finals venue and specialized transportation. Please note that transportation is not available from non-official hotels.

VIP and Guest entry fees do not include Field of Play access for qualification or elimination rounds.

The official accommodations are BCMInns, Parkland Motels I & II, Ramada and Canalta Hotels. There are also a limited number of Cabins (10) and Tipis (2) that accommodate larger groups. Due to limited capacity, a "First Come, First Serve" policy will be followed. All accommodations are serviced by the event shuttle.

Teams who do not reserve their accommodation through the organizing committee will be charged 100USD/day of competition/individual as per the <u>Policies and Procedures Athletes</u>, <u>Officials and Team</u> <u>Management</u>.

• Final Hotel Reservation & Transportation on or before **7 August 2024**

To confirm the reservation, a 50% deposit of the total amount is required to be bank transferred to the LOC on or before **15 July 2024**. Reservations after this date will be considered only according to availability.

IMPORTANT!

There will be a limited number of rooms at each hotel. To ensure that you stay at your preferred hotel, please book your hotel as soon as possible. Reservations are only final after the LOC has received the deposit of 50%. Due to limited capacity, a 'First Come, First Serve' policy will be followed. According to the availability of the rooms, the LOC reserves the right to direct the teams to hotels of the same level. None of the accommodations has a full-service restaurant on the premises.

Half Board rates are per room, per night, breakfast*, lunch and local transportation.

Full Board rates are per room, per night, breakfast*, lunch, dinner and local transportation.

Teams that do not select Full Board will be responsible for arranging their own dinner meal.

*Cabin and Tipi accommodations do not include breakfast.

In addition, the LOC will not be responsible for providing event information to any hotel that is not on the official accommodation list.

Teams that book non-official accommodation will need to register at the accreditation desk no later than the day before the official practice day. Failing to do so will result in no changes being made to the entry list and it is likely that participation in the event will be refused if registration is not completed in time.

CANCELLATION POLICY

Cancellations & Changes

All cancellations and changes must be made through WAREOS.

- Cancellations received **before 14 August 2024**, a full refund will be given.
- Cancellations received **after 14 August 2024**, no refund will be given.
- Refunds will be processed after the event.
- All cancellations and changes must be made through WAREOS. Changes made to the athlete and/or team official names after the final entry deadline date and within 3 days prior to the start of the event will be subject to a 50 CHF charge.
- The organising committee should be informed immediately about any changes in travel arrangements 72 hours prior to arrival.
- If your arrival is later than your original schedule, the room charges start from the original date indicated by the Member Association in their WAREOS accommodation reservation.

Terms and Conditions Introduction

The Member Association acknowledges to have understood and accepted in their whole and without any restrictions the sale and purchase terms and conditions of this invitation package, and of the registration platform https://extranet.worldarchery.s port/wareos/.

Consequently, the Member Association who wishes to register to an event, and book some or all associated extras proposed by the local organizing committee acknowledges that they are fully aware present terms and conditions are accepted by entering information in WAREOS.

Any Member Association declares that it is entitled to enter a contractual relationship with the Local Organising Committee of the event in accordance with these terms and conditions.

The Local Organising Committee commits itself to communicate, within reason, to its potential clients the greatest information available on the following topics:

Description of the main characteristics of the proposed products and of their use. Pricing Information on the methods of payment and reimbursement conditions.

Article 1: Entirety

The platform <u>https://extranet.worldarchery.s</u> <u>port/wareos/</u> is the propriety of, has been designed and created and is managed by World Archery Federation at Lausanne, Switzerland, and put at the disposal of the Local Organising Committee to facilitate registration to World Archery events.

The present terms and conditions include any and all rights and obligations of the parties. No single, specific, or general term or condition that may appear on documentation sent, given, or handed over to a Member Association will alter, replace, or complete parts of or the entirety of these terms and conditions

World Archery reserves the right to modify at any time and without any preliminary notification of any kind these terms and conditions.

Article 2: Object

The present terms and conditions define the rights and obligations of the parties in relation to the registration made through the platform <u>https://extranet.worldarchery.s</u> <u>port/wareos/</u> of services offered by the Local Organising Committee in the scope of the event it has been set for.

Article 3: Contractual documents

The present terms and conditions and the registration process make up the contractual documents between the parties.

Article 4: Electronic signature:

The Member Association's entering registration information is the electronic signature which is binding between the parties in the same sense as a handwritten signature would be.

Article 5: Registration Confirmation – Contract

The contract is validated as soon as the Member Association has entered its preliminary registration by entering information in WAREOS. A modification of the registration is possible until the deadline for registration set in the document. Modifications may be subject to penalty fees.

Article 6: Prices

The official prices are listed in the "Policies and Procedures Athletes, officials and team management", the invitation package prices will be based on the official price list, converted to the currency elected by the LOC for invoicing (CHF, EUR, or USD).

The official prices valid on the date that the registration confirmation is sent to the



Member Association are binding between the parties.

Article 7: Payment methods

All payments shall be made by bank transfer to the organising committee respecting the stated deadlines, with all bank charges paid by the Member Association. For any open invoices that are not settled 21 days prior the beginning of the event, the Local Organising committee will be entitled to charge a 5% surcharge on all open amounts.

Any payments received cash by World Archery on behalf of the organising committee will incur a 10% additional service fee, to be paid to World Archery.

Article 8: Payment deadlines and refunds

After the final deadlines of registration mentioned in this document, Member Association will not be entitled to any refund, and all remaining unpaid amounts shall be paid to the Local Organising Committee.

Failure to do so, will results in an immediate suspension of the Member Association, who will be set as not in good standing on the day of the official practice of the event, and so until the full amount is paid to the LOC.

The availability of services is guaranteed on a first come, first serve basis, provided that the payment of such service has been paid to the local organising committee, partially or in full as mentioned in this document.

The local organising committee is not required to hold services for a Member Association that as not paid in full such service.

Article 10: Force-majeure

None of the two parties will have failed in their respective contractual obligations if their execution is delayed or prevented by a case of forcemajeure. Cases considered to be a force majeure are extraordinary events or circumstances beyond the control of the parties, such as a war, strike, riot, crime, or an event described by the legal term "act of God" (e.g., flooding, earthquake, volcano eruption, etc). However, force majeure is not intended to excuse negligence or other malfeasance of a party, as where non-performance is caused by the usual and natural consequences of external forces, or where the intervening circumstances are



specifically contemplated. The party experiencing a force majeure must notify in writing with 24 hours after becoming aware of the occurrence. The parties will then, within 7 business days examine, unless the force majeure prevents it, if and how the contractual obligations will be met.

Article 11: Privacy statement

All information exchanged by the Parties will be treated with the utmost confidentiality.

All information requested by World Archery and the Organising Committee from the Member Association are necessary to process the event registration and can therefore be communicated only to the contractual partners of World Archery and the Local Organising Committee.

World Archery and the Local Organising committee are authorized to send informative and promotional e-mails to the Member Association, using the WAREOS e-mail address and the contact person provided by the Member Association during the registration.
