

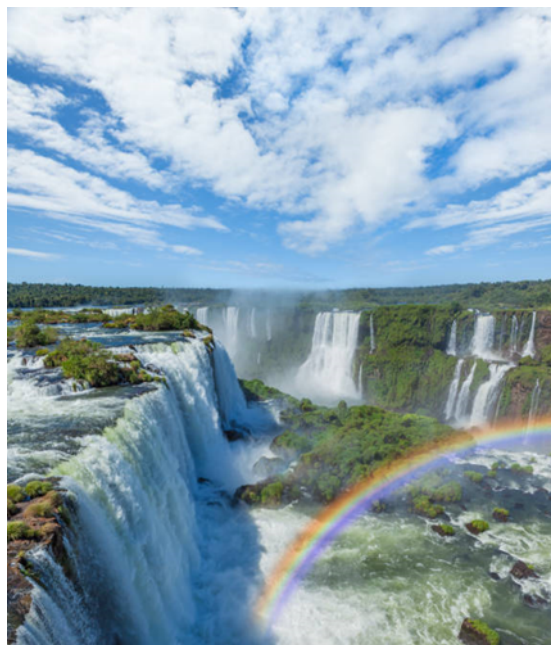
## TO ALL WORLD ARCHERY MEMBER ASSOCIATIONS

## **PRELIMINARY & FINAL REGISTRATION**

All entries, accommodation reservations, transport needs, flight arrival/departure information and letter requests are to be completed using the World Archery Online Registration System WAREOS <https://extranet.worldarchery.sport>. This system handles the entire registration process for this event. No entry forms, hotel reservations or transportation forms will be accepted; all information must be entered into WAREOS.

Member associations can login to WAREOS at <http://extranet.worldarchery.sport> with the username and password assigned by World Archery. After entering WAREOS, selecting the event from the list will allow a member association to register their athletes. Select/press the “Entries” button to see the list of categories in the event. Select/press the “category” to enter the athlete and official numbers/details participating for that event. A WAREOS User Manual can be downloaded in PDF format (English) upon login.

**There is no limit to the number of athletes a country may enter in each category**

Member Associations can only use WAREOS to make any changes, amendments or cancellations to entries and will be able to do so at any time. An email will automatically notify the Organizing Committee and Member Association of any changes made in WAREOS.

## **CLUB ARCHERS' PARTICIPATION**

Other athletes (not competing as a country but only as a club) can register on Open WAREOS at <https://extranet.worldarchery.sport/> with their username and password if they have registered in the past or register for login details if this is the first time.

After creating the profile, follow the instructions to register for the event.

Please contact World Archery ([wareos@archery.sport](mailto:wareos@archery.sport)) if you have technical problems at WAREOS. For any questions regarding the organization of the event (transportation, lodging, meals, etc.), please contact the LOC directly.

Archers who register using Open WAREOS may compete only as individuals. They may not be part of teams or mixed teams.

## **EVENTS**

The Championship will include individual, team and mixed team events in the categories:

- **Recurve** - Men and Women - RM / RW
- **Recurve U21** - Men and Women - RU21M / RU21W
- **Recurve U18** - Men and Women - RU18M / RU18W
- **Recurve U15** - Men and Women - RU15M / RU15W
- **Recurve 50+** - Men and Women - R50M / R50W
- **Compound** - Men and Women - CM / CW

- **Compound U21** - Men and Women - CU21M / CU21W
- **Compound U18** - Men and Women - CU18M / CU18W
- **Compound U15** - Men and Women - CU15M / CU15W
- **Compound 50+** - Men and Women - C50M / C50W
- **Barebow** - Men and Women - BM / BW
- **Barebow U21** - Men and Women - BU21M / BU21W
- **Barebow U18** - Men and Women - BU18M / BU18W
- **Barebow U15** - Men and Women - BU15M / BU15W
- **Barebow 50+** - Men and Women - B50M / B50W

Each archer may participate in only one category.

A minimum of 3 teams will be required to have a team or mixed team competition.

## INTERNATIONAL LICENSES

The World Ranking Tournament will be a valid event for the World Ranking.

That is why all athletes who are registered by their National Federations using WAREOS (not Open WAREOS) will have to pay the international license to World Archery with a value of 100 Swiss Francs.

**\*The registration fees DO NOT INCLUDE the transfer from the airport to the hotels.**

The registration fees INCLUDE daily local transportation to and from the shooting range to/from the official hotels during the qualification, elimination and final rounds (schedules to be confirmed). This service is enabled only for delegations and archers who have booked hotels through the official channel of the event organization (Wareos).

Teams that do not book their accommodation with the Organizing Committee will not be entitled to airport transfers coordinated by the LOC, nor daily transfers to the event.

Any changes made after the specified deadlines or if entries differ by more than 4 athletes from the preliminary entries, the following penalties will be automatically applied.

Penalty to be paid to the Organizing Committee:	Cost (USD):
Penalty for late entries (after the final deadline)	<b>50</b> per entry
If the final entries differ from the preliminary entries by more than 4 athletes/officials.	<b>150</b> per entry
Not having made preliminary entries before the deadline, but then having submitted final entries.	<b>150</b> per entry

Any entry received less than 3 days prior to the Team Manager's meeting for the event will be rejected if a preliminary and/or final entry is not made earlier. This decision cannot be appealed by teams and is in full compliance with current World Archery rules, article 3.7.1.2.

Entries received after the deadline are subject to penalties, as clearly indicated in the rule book and invitation documents.

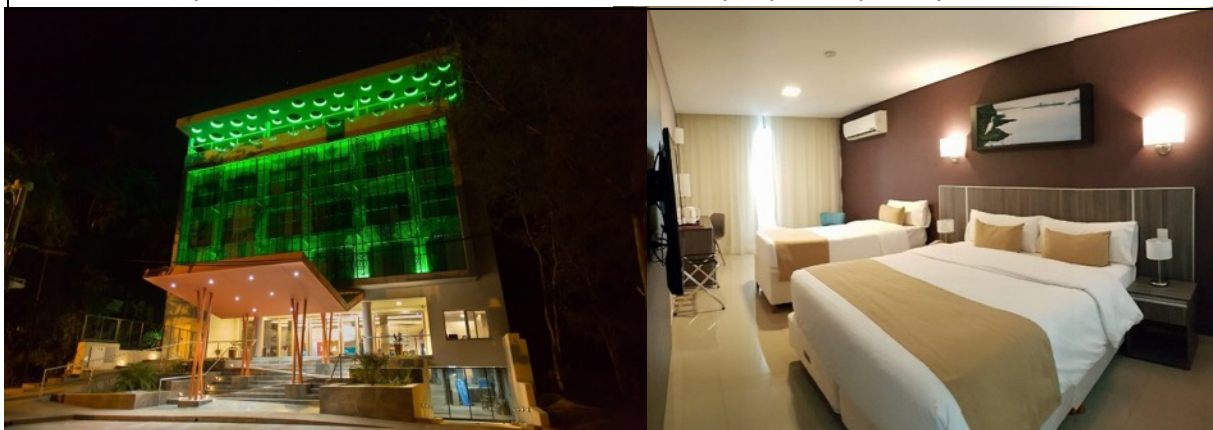
A member association that has made final entries in WAREOS and does not participate will be invoiced for the number of entries entered into the system, unless it has informed World Archery and the Organizing Committee in writing at least one week prior to the event that it is unable to attend.

#### ❖ LUNCH

On the site there is a canteen and facilities to purchase lunch.

#### ❖ CLOSING DINNER

Friday, September 6th, a closing dinner will be held, including a night catamaran ride on the rivers of the triple frontier, live music show and dinner. Cost USD 40 per person.

#### ❖ TRANSPORTATION

Transportation will be provided from the Iguassu Falls International Airport (IGR), or Foz Iguazu International Airport in the city of Foz do Iguazu, Brazil, to the official hotel, if booked through WAREOS, from 15 days before the official practice day and up to one day after the closing day.

A pick-up/drop-off fee will be charged at the airport:

- From Puerto Iguazu airport, both legs, **USD 24.-** per person.
- From Foz do Brazil airport, both legs, **USD 140.-** per person.

Shuttle service transportation to the event will be available between the official hotel, the practice and the competition venue from September 3, 2024. Shuttle schedules will be confirmed.

#### ❖ VISA

All participants who need an entry visa to Country, will be required to complete the Visa Support sections in WAREOS by no later than 3th July of 2024.

It is the applicants' responsibility for supplying the necessary information, ensuring all details are up to date, correct and submitted by the deadlines specified.

In addition, all participants that require a visa are kindly requested to supply a copy of their latest/valid passport. Copies of each application can be uploaded on WAREOS.

All passport copies and personal details entered/uploaded to WAREOS will be held securely and in the strictest of confidence and not shared with other parties.

#### ❖ TERMS OF PAYMENT

Complete all the necessary sections in WAREOS and make full payment within the specified deadlines. Credit cards will not be accepted. All expenses will be paid by the participants.

Entrance fees must be paid in full prior to arrival.

To confirm hotel reservations, a minimum deposit of 50% of the total amount is required to be transferred to the LOC by July 3, 2024. Reservations after this date will be considered based on availability only. Accommodation cannot be guaranteed after this deadline. The final outstanding balance will be made by August 03, 2024. An invoice will be provided by WAREOS.

❖ **CANCELLATIONS & CHANGES**

All cancellations and changes must be made through WAREOS / Open WAREOS:

- Cancellations received before July 20, 2024; a full refund of the accommodation deposit will be made.
- Cancellations received after August 3, 2024; no transportation refund will be granted.
- Refunds will be processed after the event.
- Name changes to team officials or athletes (same category) will be accepted up to two (2) days before the official practice without any additional charge or penalty, after this, they will have a cost of 50 u\$s.
- If flight arrival details change at the last minute, please contact the Organizing Committee using the details provided in the team managers' brochure.
- If a participant's arrival is later than the originally scheduled arrival date, the room will be charged from the date of the original WAREOS reservation.
- An e-mail will automatically notify the Organizing Committee and the Member Association of any changes made in WAREOS.

❖ **TRAINING**

A training field will be available starting on 2nd September at the qualification field located approximately 15 minutes from the official hotels. Transport to training will be made available from 3rd September.

❖ **WEATHER**

Temperatures in September are expected to range between 15 and 26 degrees Celsius. On average there are 7 days of precipitation in the month of September.

## **Terms and Conditions**

### **Introduction**

The Member Association acknowledges to have understood and accepted in their whole and without any restrictions the sale and purchase terms and conditions of this invitation package, and of the registration platform <https://extranet.worldarchery.sport/wareos/>.

Consequently, the Member Association who wishes to register to an event, and book some or all associated extras proposed by the local organizing committee acknowledges that they are fully aware present terms and conditions are accepted by entering information in WAREOS.

Any Member Association declares that it is entitled to enter a contractual relationship with the Local Organising Committee of the event, in accordance with these terms and conditions.

The Local Organising Committee commits itself to communicate, within reason, to its potential clients the greatest information available on the following topics:

Description of the main characteristics of the proposed products and of their use.

Pricing

Information on the methods of payment and reimbursement conditions.

### **Article 1:**

#### **Entirety**

The platform <https://extranet.worldarchery.sport/wareos> is the propriety of, has been designed and created and is managed by World Archery Federation at Lausanne, Switzerland, and put at the disposal of the Local Organising Committee to facilitate registration to World Archery events.

The present terms and conditions include any and all rights and obligations of the parties. No single, specific, or general term or condition that

may appear on documentation sent, given, or handed over to a Member Association will alter, replace, or complete parts of or the entirety of these terms and conditions

World Archery reserves the right to modify at any time and without any preliminary notification of any kind these terms and conditions.

### **Article 2:**

#### **Object**

The present terms and conditions define the rights and obligations of the parties in relation to the registration made through the platform <https://extranet.worldarchery.sport/wareos/> of services offered by the Local Organising Committee in the scope of the event it has been set for.

### **Article 3:**

#### **Contractual documents**

The present terms and conditions and the registration process make up the contractual documents between the parties.

### **Article 4:**

#### **Electronic signature**

The Member Association's entering registration information is the electronic signature which is binding between the parties in the same sense as a handwritten signature would be.

### **Article 5:**

#### **Registration Confirmation–Contract**

The contract is validated as soon as the Member Association has entered its preliminary registration by entering information in WAREOS. A modification of the registration is possible until the deadline for registration set in the

document. Modifications may be subject to penalty fees.

#### **Article 6:**

##### **Prices**

The official prices are listed in the “Policies and Procedures Athletes, officials and team management”, the invitation package prices will be based on the official price list, converted to the currency elected by the LOC for invoicing (CHF, EUR, or USD).

The official prices valid on the date that the registration confirmation is sent to the Member Association are binding between the parties.

#### **Article 7:**

##### **Payment methods**

All payments shall be made by bank transfer to the organising committee respecting the stated deadlines, with all bank charges paid by the Member Association. For any open invoices that are not settled 21 days prior the beginning of the event, the Local Organising committee will be entitled to charge a 5% surcharge on all open amounts.

Any payments received cash by World Archery on behalf of the organising committee will incur a 10% additional service fee, to be paid to World Archery.

#### **Article 8:**

##### **Payment deadlines and refunds**

After the final deadlines of registration mentioned in this document, Member Association will not be entitled to any refund, and all remaining unpaid amounts shall be paid to the Local Organising Committee.

Failure to do so, will results in an immediate suspension of the Member Association, who will be set as not in good standing on the day of the official practice of the event, and so until the full amount is paid to the LOC.

#### **Article 9:**

##### **Availability of services**

The availability of services is guaranteed on a first come, first serve basis, provided that the payment of such service has been paid to the

local organising committee, partially or in full as mentioned in this document.

The local organising committee is not required to hold services for a Member Association that as not paid in full such service.

#### **Article 10:**

##### **Force-majeure**

None of the two parties will have failed in their respective contractual obligations if their execution is delayed or prevented by a case of force-majeure. Cases considered to be a force majeure are extraordinary events or circumstances beyond the control of the parties, such as a war, strike, riot, crime, or an event described by the legal term "act of God" (e.g., flooding, earthquake, volcano eruption, etc). However, force majeure is not intended to excuse negligence or other malfeasance of a party, as where non-performance is caused by the usual and natural consequences of external forces, or where the intervening circumstances are specifically contemplated. The party experiencing a force majeure must notify in writing with 24 hours after becoming aware of the occurrence. The parties will then, within 7 business days examine, unless the force majeure prevents it, if and how the contractual obligations will be met.

#### **Article 11:**

##### **Privacy statement**

All information exchanged by the Parties will be treated with the utmost confidentiality

All information requested by World Archery and the Organising Committee from the Member Association are necessary to process the event registration and can therefore be communicated only to the contractual partners of World Archery and the Local Organising Committee.

World Archery and the Local Organising committee are authorized to send informative and promotional e-mails to the Member Association, using the WAREOS e-mail address and the contact person provided by the Member Association during the registration.
