# Dear Presidents,

We invite you to join us at the Americas Para Cup Stage 1: 2025 Morelia Para-Archery Championship World Ranking Event. Morelia is waiting for your athletes to compete while experiencing the culture, food, and history of the city. Built in the 16th century, Morelia is an outstanding example of urban planning which combines the ideas of the Spanish Renaissance with the Mesoamerican experience. Well-adapted to the slopes of the hill site, its streets still follow the original layout. More than 200 historic buildings, all in the region's characteristic pink stone, reflect the town's architectural history, revealing a masterly and eclectic blend of the medieval spirit with Renaissance, Baroque and neoclassical elements. Morelia was the birthplace of several important personalities of independent Mexico and has played a major role in the country's history.

The tournament will be held at the Sport Center complex "Ejercito de la Revolucion" (CDER) just east of the Historic downtown Morelia.

To compete in the U21 categories archers must have been born in 2005 or after.

Target face for U21 Open categories will be the 40cm (5-ring) triple face at 18 meters.

Target face for the W1 events at 18 Meters will be the single full-size 40cm face.





# **CLASSIFICATION**

Classification for Physically Impaired Athlete will be offered on **Wednesday**, **July 16**<sup>th</sup>, the day before Official Practice, at the hotel Mansion Solis located in Av. Acueducto 344 Col. Chapultepec Norte C. P. 58260 Morelia, Michoacán, México.

Requests and documents (medical intake form and additional medical documents) must be filled out in English and sent by their National Federation to <a href="mailto:classification@archery.sport">classification@archery.sport</a> no later than June 16<sup>th</sup> 2025. Hand-written forms will not be accepted. Please submit a passport sized color picture (jpeg) along with the MIF.

It is the full responsibility of teams to arrive on time. It will not be possible to postpone the classification session or official practice nor equipment inspection. It is recommended to the archers registered for classification arrive one day before their scheduled classification.

### PRELIMINARY AND FINAL REGISTRATION

All entries, accommodation reservations, transport needs, flight arrival/departure information and visa invitation letter requests are to be completed using the World Archery Online Registration System WAREOS:

This system handles the entire registration process for this event. No entry forms, hotel reservations or transportation forms will be accepted; <u>all information must be entered into WAREOS</u>.

Member associations can login to WAREOS at <a href="https://extranet.worldarchery.sport/">https://extranet.worldarchery.sport/</a> with the username and password assigned by World Archery. After entering WAREOS, selecting the event from the list will allow a member association to register their athletes. Select/press the "Entries" button to see the list of categories in the event. Select/press the "category" to enter the athlete and official numbers/details participating for that event. A WAREOS User Manual can be downloaded in PDF format (English) upon login.

Contact (<u>wareos@archery.sport</u>) with any questions regarding <u>technical problems on WAREOS</u>. For any question regarding the organization of the event (transportation, accommodation, meals, etc.) please contact **the LOC directly**.

There is no limit in the number of athletes per country that can register into each category and divisions of the event.

Member Associations can only use WAREOS to make any changes or amendments to entries and will be able to do so at any time. An email will automatically notify the Local Organizing Committee and Member Association of any changes made in WAREOS.





# **CLUB ARCHER'S PARTICIPATION**

Other athletes (not competing as country but only as club) can register on Open WAREOS at <a href="https://extranet.worldarchery.sport/">https://extranet.worldarchery.sport/</a> with their username and password if already registered in the past or register to get the log in details for first-time users. After the creation of the profile, follow the instructions to register for the event. Contact (<a href="wareos@archery.sport">wareos@archery.sport</a>) in the World Archery Office with any questions regarding technical problems on WAREOS.

For any question regarding the organization of the event (transportation, accommodation, meals etc.) please contact directly the LOC.

Club archers must have a valid international classification card and must comply with the documentation requirements and deadlines set forth above in the Classification section. Archers who do not have a valid international classification card cannot register through open WAREOS.

Archers who register through Open WAREOS can compete in the **individual events only**: they are ineligible to compete in either the doubles or the mixed team events.

### VISA

All participants who need an entry visa to Mexico will be required to complete the Visa Support sections in WAREOS by no later than May 20<sup>th</sup>, 2025. It is the applicants' responsibility for supplying the necessary information, ensuring all details are up to date, correct and submitted by the deadlines specified. In addition, all participants that require a visa are kindly requested to supply a copy of their latest/valid passport. Copies of each application can be uploaded on WAREOS. All passport copies and personal details entered/uploaded to WAREOS will be held securely and in the strictest of confidence and not shared with other parties.





#### **FEES**

#### **ENTRY FEES**

Individual:	<b>260 USD</b> per athlete
Officials (Team managers, coaches, medical staff):	<b>180 USD</b> per person
Guest:	<b>180 USD</b> per person

Please note that an International License fee of 100 CHF per participant per calendar year is to be paid to World Archery.

Entry fees for Individual/Official include daily local transport between official hotels and the qualification, elimination, and finals venues (timetable to be confirmed on site).

Entry fees for Guest include daily local transport between official hotels and the qualification, elimination, and finals venues (timetable to be confirmed on site). They have no field of play access.

All other fees applicable to the event can be found in the <u>Policies and Procedures Athletes</u>, Officials and Team Management.

Member Associations that have penalty fees outstanding from 2024 will need to have paid these penalty fees before being eligible to enter and compete.

Teams who do not arrange their accommodation with the LOC will not be entitled to airport transfers and local transport coordinated by the LOC.

Any changes that are made after the deadlines specified or if entries differ by more than 4 athletes from the preliminary entries, the following penalty fees will automatically be applied.

# Any entries received after the final registration deadline will be refused. Only substitutions will be allowed.

Entries and substitutions received after the deadlines are subject to penalties as clearly stated in the rule book and the world ranking event invitation documents. A Member Association that has made final entries in WAREOS and does not participate will be invoiced for the number of entries entered in the system as well as any other booking they made through the platform (including but not limited to accommodation, transportation, and any other extras the Member Association has booked through the platform).

# CANCELLATIONS / CHANGES

All cancellations and changes must be made through WAREOS or Open WAREOS:

- Please refer to Article 5 of the terms and conditions at the end of this package.
- In the event of last-minute flight arrival changes please contact the LOC using the details indicated in the Team Managers' Booklet.
- If a participant's arrival is later than the originally scheduled arrival date, then the room will be charged from the date of the booking in WAREOS.
- An email will automatically notify the LOC, and the Member Association of any changes made in WAREOS.

The value of the invoices will be issued in dollars, all bank charges will be paid by the participants.

### **TRANSPORTATION**

Transportation will be provided from Morelia International Airport (MLM) "Gral. Francisco Mujica" to the participating hotels named in this invitation package.

Event shuttle transport will be available between the participating hotels and the competition venue and FOP starting **Thursday**, **July 16**<sup>th</sup> . Transport timetables will be confirmed.

Team doctors are allowed to practice on their national team and all prescriptions and investigations must be arranged through the LOC medical team.

- Players under treatment by prohibited medicine in Mexico such as (marijuana) they should provide medical report with medical prescription at the airport (Mexican customs if they requested)
- Importation of medical equipment: A template form will be sent to participating teams if requested.

#### Introduction

Consequently, the Member Association who wishes to register to an event, and book some or all associated extras proposed by the local organizing committee acknowledges that they are fully aware present terms and conditions are accepted by entering information in WAREOS.

Any Member Association declares that it is entitled to enter a contractual relationship with the Local Organising Committee of the event, in accordance with these terms and conditions.

The Local Organising Committee commits itself to communicate, within reason, to its potential clients the greatest information available on the following topics:

Article 1: Entirety

The platform https://extranet.worldarchery.sport/ wareos/ is the propriety of, has been designed and created and is managed by World Archery Federation at Lausanne, Switzerland, and put at the disposal of the Local Organising Committee to facilitate registration to World Archery The present terms and conditions include any and all rights and obligations of the parties. No single, specific, or general term or condition that may appear on documentation sent, given, or handed over to a Member Association will alter, replace, or complete parts of or the entirety of these terms conditions

World Archery reserves the right to modify at any time and without any preliminary notification of any kind these terms and conditions.

#### Article 2: Object

The present terms and conditions define the rights and obligations of the parties in relation to the registration made through the platform

https://extranet.worldarchery.sport/ wareos/ of services offered by the Local Organising Committee in the scope of the event it has been set for. Article 3: Contractual documents
The present terms and conditions
and the registration process make up
the contractual documents between
the parties.

#### Article 4: Electronic signature:

The Member Association's entering registration information is the electronic signature which is binding between the parties in the same sense as a handwritten signature would be.

# Article 5: Registration Confirmation – Contract

The contract is validated as soon as the Member Association has entered its preliminary registration by entering information in WAREOS. A modification of the registration is possible until the deadline for registration set in the document. Modifications may be subject to penalty fees.

#### Article 6: Prices

The official prices are listed in the "Policies and Procedures Athletes, officials and team management", the invitation package prices will be based on the official price list, converted to the currency elected by the LOC for invoicing (CHF, EUR, or USD).





The official prices valid on the date that the registration confirmation is sent to the Member Association are binding between the parties.

Article 7: Payment methods

All payments shall be made by bank transfer to the organising committee respecting the stated deadlines, with all bank charges paid by the Member Association. For any open invoices that are not settled 21 days prior the beginning of the event, the Local Organising committee will be entitled to charge a 5% surcharge on all open amounts.

Any payments received cash by World Archery on behalf of the organising committee will incur a 10% additional service fee, to be paid to World Archery.

Article 8: Payment deadlines and refunds

After the preliminary entry deadline, the downpayment of 50% shall not be reimbursable. After the final deadlines of registration mentioned in this document, Member Association will not be entitled to any refund, and all remaining unpaid amounts shall be paid to the Local Organizing Committee.

Failure to do so will result in an immediate suspension of the Member Association, who will be set as not in good standing on the day of the official practice of the event, and so until the full amount is paid to the LOC.

Article 9: Availability of services

The availability of services is guaranteed on a first come, first serve basis, provided that the payment of such service has been paid to the local organising committee, partially or in full as mentioned in this document.

The local organising committee is not required to hold services for a Member Association that as not paid in full such service.

Article 10: Force-majeure

None of the two parties will have failed in their respective contractual obligations if their execution is delayed or prevented by a case of force-majeure. Cases considered to be a force majeure are extraordinary events or circumstances beyond the control of the parties, such as a war, strike, riot, crime, or an event described by the legal term "act of God" (e.g., flooding, earthquake, volcano eruption, etc). However, force majeure is not intended to excuse negligence or malfeasance of a party, as where nonperformance is caused by the usual and natural consequences of external forces, or where the intervening circumstances are specifically contemplated. The party experiencing a force majeure must notify in writing with 24 hours after becoming aware of the occurrence. The parties will then, within 7 business days examine, unless the force majeure prevents it, if and how the contractual obligations will be met.

Article 11: Privacy statement All information exchanged by the Parties will be treated with the utmost confidentiality All information requested by World the Archery and Organising Committee from Member the Association are necessary to process the event registration and can therefore be communicated only to the contractual partners of World Archery and the Local Organising Committee.

World Archery and the Local Organising committee are authorized to send informative and promotional e-mails to the Member Association, using the WAREOS e-mail address and the contact person provided by the Member Association during the registration.
