Text of the motion (*)	<p>1.14 The Board of Justice and Ethics (See Appendix 1-Congress Procedures, Appendix 3-Procedure for the Board of Justice and Ethics.)1.14.1Congress shall appoint a Board of Justice and Ethics of five members to investigate alleged breaches of the WorldArchery Constitution and Rules, including its Code of Ethics and Conduct by any members of the World ArcheryFamily. However, the Board of Justice and Ethics does not consider Anti-Doping Rules violations which are under the responsibility of the Anti-Doping Panel <u>The same procedure will apply for cases of safeguarding when confidentiality reasons might need a different process as defined in the Procedures on the Safeguarding.</u></p> <p>1.14.4 Cases can be submitted through the Secretary General or the <u>Safeguarding officers</u> to the Board of Justice and Ethics by: The President;The Executive Board;The Executive Committee;Member Associations;Continental Associations;Judges or Juries of Appeal, for cases arising in tournaments under their supervision <u>and by athletes or others for safeguarding cases through the process defined in the safeguarding procedures.</u>1.14.5The Board of Justice and Ethics shall ensure procedural fairness for all parties involved.</p> <p>1.15 Sanctions (Except Anti-Doping Rules violations <u>and safeguarding violations.</u>)</p> <p>1.15.1 The Board of Justice and Ethics shall submit a detailed report on each examined case that shall also propose:Dismissal of the case as irrelevant;Acquittal;Sanctions to be imposed.</p>

	<p>1.15.2 Sanctions can be:Public reprimand;Withdrawal of record recognition;Withdrawal of awards and prizes;Temporary or partial suspension;Expulsion;Any combination of the above.</p> <p>1.15.3 An expelled Member of World Archery or one or more of its Members may re-apply as provided in the final decision or if not addressed in the final decision, then at the earlier of the next Congress or after two years have elapsed.Notwithstanding the prior sentence, the Executive Committee may permit an expelled Member to be considered for membership at an earlier date in extraordinary or compelling circumstances.</p> <p>1.15.4 Applications submitted according to Article 1.15.3. shall be dealt with by the Executive Board, which shall circulate it with a recommendation to all Member Associations and submit the application for decision by Congress.</p> <p>1.15.5 The costs of the investigation of a case may be charged to the party found guilty.</p> <p>1.15.6 Decisions on the Board of Justice and Ethics recommendations shall be taken by the Executive Board except for safeguarding violations as deccribed in the safeguarding procedures. In cases brought against elected officers for alleged misuse of office, or if the expulsion of a Member of World Archery isrecommended, the recommendation shall be circulated to all Member Associations and submitted for decision byCongress. For cases where Congress decision is requested, the Executive Board can impose a provisional suspensionprior to the matter's being considered by Congress.</p> <p>1.15.7 Executive Board, or Congress decisions, as the case may be, are final but subject to 1.31. Court of Arbitration forSport.</p> <p>1.15.8 All sanctions shall be communicated to the parties concerned, to all Members and to all World Archery Judges within10 days from the date of a decision</p>
7. Reason	Introduce a separate section on Safeguarding in the Ethics Code and the procedures of the board of Justice to protect the victims of harassment.
