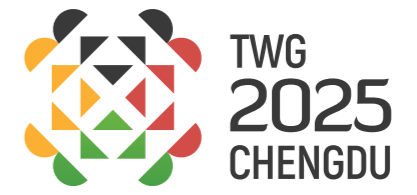

2 About the Host

2.1 Sichuan Province

Situated in southwest China and on the upper reaches of the Yangtze River, Sichuan is renowned as the “Land of Abundance”. It covers an area of 486,000 square kilometres and borders with seven provinces (including autonomous regions and municipalities directly under the central government), namely, Chongqing, Guizhou, Yunnan, Xizang, Qinghai, Gansu, and Shaanxi. The province has a permanent resident population of over 83 million.

Boasting a long history, Sichuan is the cradle of ancient Shu civilisation, and the place where “Jiaozi”, the earliest banknote in the world, was born. Shu Brocade and Sichuan Shadow Play have been included in UNESCO’s list of intangible cultural heritage. In particular, Sanxingdui Site and Jinsha Site epitomise the resplendent and mysterious civilisation of ancient Sichuan.

The province also abounds in tourism resources. Among the 26 global tourism resources and brands, there are 3 World Natural Heritage Sites including Jiuzhaigou Valley, Huanglong Scenic and Historic Interest Area and Sichuan Giant Panda Sanctuaries, 1 World Cultural Heritage Site (Mount Qingcheng and the Dujiangyan Irrigation System), and 1 World Cultural and Natural Heritage Site (Mount Emei and Leshan Giant Buddha Scenic Area).

Sichuan is active in external exchanges. As of December 2024, it has established friendly relations with 500 provinces/states in 87 countries/regions, and economic and trade relations with over 200 countries/regions. A total of 381 Fortune Global 500 Enterprises have operated in Sichuan. Chengdu, the capital of Sichuan Province, is among the Chinese cities offering a 240-hour visa-free transit policy for travellers from 54 countries.

2.2 Chengdu

Chengdu is the hometown of the Giant Pandas and enjoys over 4,500 years of civilisation history and more than 2,300 years of history as a city, manifesting a perfect mixture of history, culture and modernity. Being the capital of Sichuan Province and a central city in southwest China, Chengdu covers an area of 14,300 square kilometres and has a permanent population of 21.4 million, which has turned it into a megacity known to the world. It is also an important centre of economy, science and technology, finance, cultural creativity, and international exchanges in China, and an international hub for comprehensive transportation and communications.

Today’s Chengdu values opening up with global vision. In total, 23 countries have been approved to

establish consulates in Chengdu. And the city has established sister-city and friendship city relations with 113 cities around the world, and trade relations with 235 countries/regions worldwide. Chengdu is the third city having two international airports on the Chinese mainland, following Shanghai and Beijing, and the 19th city with two 4F airports in the world. In 2024, the passenger throughput exceeded 87 million. As of December 2024, it has opened 73 regular international and regional flight routes, covering both passenger and freight services. In addition, it is linked to 118 overseas cities through its international freight train services.

Chengdu has been awarded as the City of Gastronomy by UNESCO for its world-renowned Sichuan cuisine, great variety of delicious street food, and tasty spicy hot pot. It is also selected by UNWTO as China’s Best Tourist City. Tianfu culture, the bedrock of Chengdu’s city culture, has been nourishing the people and the city with the spirits of valuing innovation, creativity, elegance, fashion, optimism, inclusiveness, friendship, and public welfare. Chengdu has successfully held the Chengdu FISU World University Games, the Thomas & Uber Cup Finals 2024, among other major international events. Culture and sports have become the two focal points as Chengdu is going global in a more open and confident manner.

3 About TWG 2025 Chengdu

3.1 Overview

On 9 May 2019, at the Annual General Meeting of the International World Games Association held in Gold Coast, Australia, Chengdu successfully won the bid to host The World Games 2025. TWG 2025 Chengdu will be held from 7 to 17 August 2025, with a total of 60 disciplines under 34 sports competed in 27 venues in 8 venue clusters.

3.2 Slogan, Logo and Mascots

3.2.1 Slogan

“Boundless Sports, Countless Wonders”, the slogan implies that Chengdu is a land of promise where tradition and modernity coexist harmoniously. The city presents a delightful contrast between the fast pace of a metropolis and the residents’ slow lifestyle. Moreover, the leisurely atmosphere in its streets and lanes complements the competitive spirit of sportsmanship. Sports, like a dazzling spark, ignite the infinite potential and possibilities of this city, making happiness prevail in this land of countless wonders.

4.2 Access Rights and Privileges

The IWGA grants zone access rights and other privileges to all accreditation applicants based on their roles, allowing them to perform their official functions in zones they are entitled to during TWG 2025 Chengdu. These rights granted cover access rights to venues and zones, as well as accommodation, transport, catering and other entitlements.

4.3 Policies and Useful Tips on Accreditation

4.3.1 Acceptable Identity Documents

All applicants shall submit one of the following forms of identity document for accreditation.

- Resident Identity Card of the People’s Republic of China, for all applicants from the Chinese mainland.
- Mainland Travel Permit for Hong Kong and Macao Residents, for all applicants from Hong Kong, China and Macao, China.
- Mainland Travel Permit for Taiwan Residents, for all applicants from Chinese Taipei.
- Passport, for all non-Chinese applicants.

Please note that non-Chinese applicants holding multiple passports need to complete registration and accreditation with the passport that will be used to travel to and from China during TWG 2025 Chengdu.

4.3.2 Accreditation Card (ID Card) Issuance Procedures

Refer to the Accreditation section in the TWG 2025 Chengdu Bulletins for ID card issuance procedures.

4.3.3 Procedure for Amending Accredited Information

- Processed on-site at TWG Village Accreditation Centre (A/B).
- For any changes involving critical personal information (surname, given name, gender, date of birth, country/region, type and number of identity document, and employer/media organisation), the concerned applicant must undergo a second-round background check.

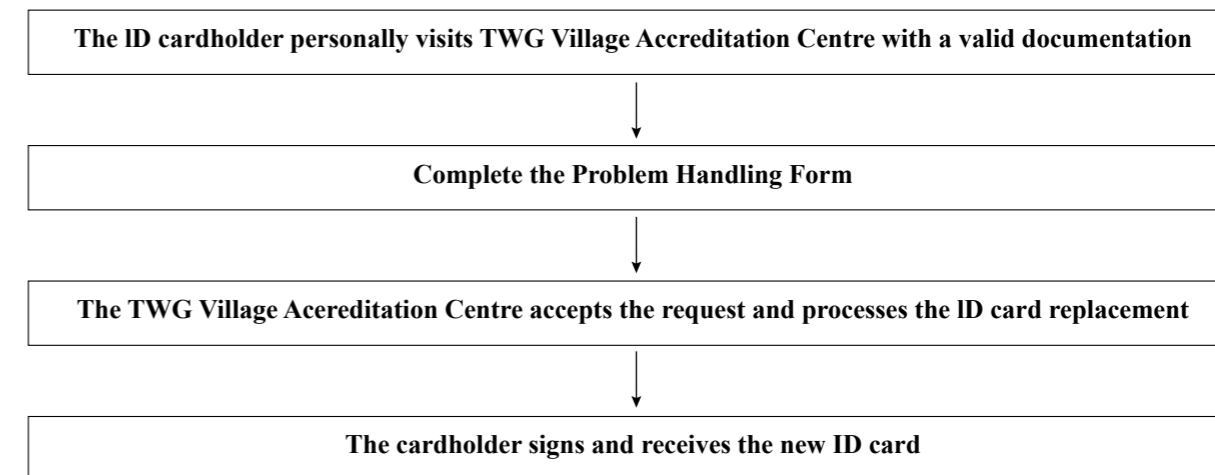


Figure 6 Procedures for Lost, Stolen or Damaged ID Cards

4.3.5 Photo Requirements for Accreditation Cards

- Coloured photo taken within the last six months to reflect your current appearance.
- Taken in front of a plain white background.
- The head (from the chin to the top of the head) should occupy 70-80% of the photo’s total height.
- At least 480 pixels (width) * 600 pixels (height) in size.

5 Entry and Visa Policy

5.1 Entry Permit and Visa Policy

Except for those who are explicitly exempt from visas, participants for TWG 2025 Chengdu must apply for a Chinese visa in advance at Chinese embassies or consulates or other overseas institutions authorised by the Chinese Ministry of Foreign Affairs (MFA).

Participants from Hong Kong, China and Macao, China must hold a valid Mainland Travel Permit for Hong Kong and Macao Residents.

Participants from Chinese Taipei must hold a valid Mainland Travel Permit for Taiwan Residents.

5.2 Visa Application Procedure and Materials for General Participants

5.2.1 Visa Application Procedure



***Regardless of visa requirements, participants are advised to obtain an invitation letter via the EMS system to access an expedited entry service.

Participants should log into the Swiss Timing Event Management System (EMS) and submit personal information to complete registration. The invitation letter can be downloaded and printed from the EMS after the registration is approved. Those who pass the registration review and confirm their participation in TWG 2025 Chengdu may apply for a Chinese visa at Chinese embassies or consulates or other overseas institutions authorised by the MFA with the invitation letter.

Chengdu ExCo suggests that foreign participants check the official websites of the Chinese embassies and consulates in their country/region of residence (please refer to the list on <https://www.fmprc.gov.cn/eng/zwjg/>) for visa policy and requirements. The application should be submitted at least 10 working days before intended travel. Participants shall follow the latest visa policy issued by the Chinese

embassies or consulates in their country/region of residence.

5.2.2 Visa Application Materials

After completing registration in the EMS, participants need to re-check the automatically generated invitation letter. The personal information on the invitation letter should be consistent with that contained in other materials submitted for visa application. The materials needed for visa application include, but are not limited to, the following items (Specific requirements are subject to the latest announcements from the Chinese embassies or consulates in the applicant's country/region of residence):

5.2.2.1 Invitation Letter

Participants can download and print a hard copy of the invitation letter from the EMS after their registrations are approved.

5.2.2.2 Passport

A passport with a validity period of not less than 6 months from the date of submission, with at least 2 blank visa pages, along with a photocopy of the biographic page.

5.2.2.3 Visa Application Form

A completed and signed Visa Application Form of the People's Republic of China, with a recent coloured photo (white background) of the applicant, measuring 48mm × 33mm. A digital copy of the photo for backup.

5.2.2.4 Notices

The submission of visa application materials can be made by the applicant in person or by an authorised representative on a voluntary basis, except when regulations require personal appearance or when the visa officer requests an interview with the applicant. The applicant is obliged to answer any questions posed by the visa officer.

6 Finance

6.1 Fees for Overseas Extra Officials

Subject to room availability and their actual needs, IF Extra Team Officials, NOC/NSO Sport Officials, display programme participants, IF Guests and NOC/NSO Guests have to pay for their accommodation and other Games-related services in TWG Village and official hotels based on provisions applying to their respective categories. Each participant group needs to make payment before they complete registration and accreditation.

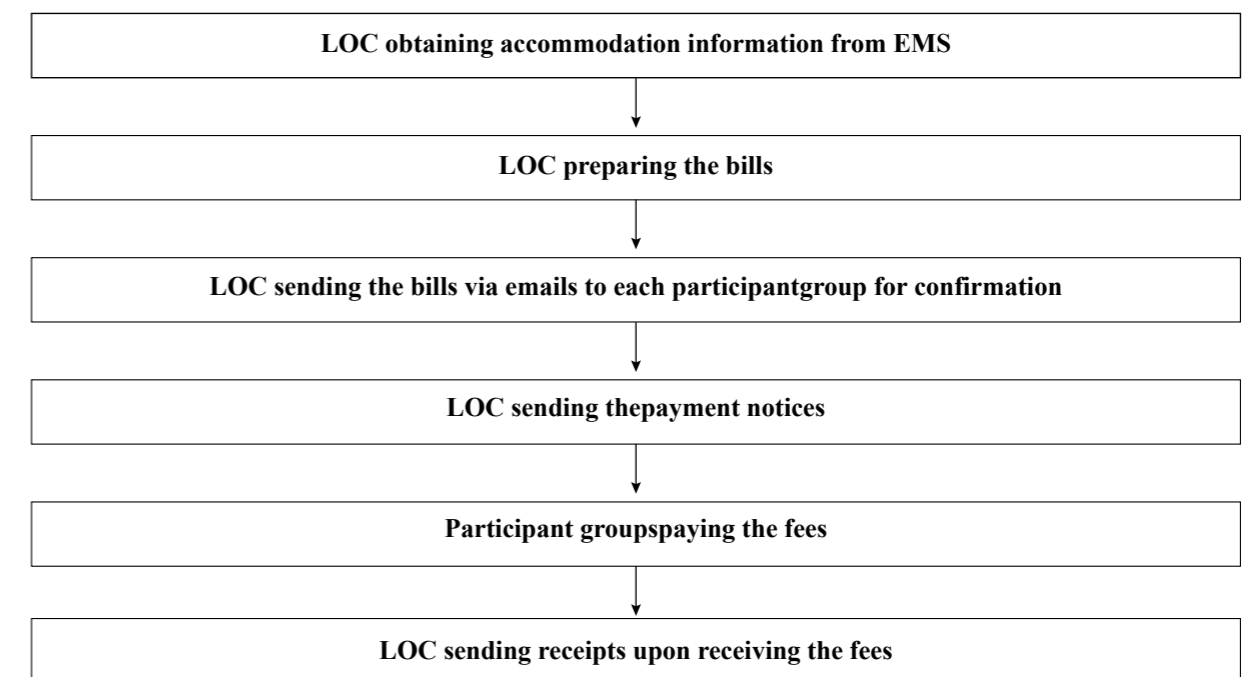


Figure 8 Fee Collection Procedures for Overseas Extra Officials

7 Arrival and Departure (AND) and Customs Clearance

7.1 Official AND Services Period

3-18 August 2025

7.2 Official Port of Entry

Chengdu Tianfu International Airport (TFU)

7.3 Official Points of Arrival and Departure

Chengdu Tianfu International Airport (for international & domestic AND)

Chengdu Shuangliu International Airport (for domestic AND)

Chengdudong Railway Station (for domestic AND)

7.4 Target Group

Accredited participants travelling to and from the Official Points of Arrival and Departure.

7.5 Detail

24-hour arrival/departure services at Tianfu Airport, Shuangliu Airport, and Chengdudong Railway Station. Service desks and dedicated drop-off/pick-up points will be established.

International Flights (Tianfu Airport):

- Arrival: Dedicated or priority customs and immigration channels.
- Departure: Dedicated check-in counters and dedicated or priority customs, immigration, and security channels.

Domestic Flights (Tianfu/Shuangliu Airports): Priority check-in counters and security channels.

Chengdudong Railway Station: Signage/staff guidance to dedicated drop-off/pick-up areas.

7.6 Arrival and Departure Information Submission

All participants should fill in and submit the arrival and departure information on EMS before 4 July 2025.

7.7 Customs Clearance Services and Tips

Chengdu ExCo will offer streamlined customs clearance services for Games-related supplies and equipment, including a customs clearance service team, recommended professional customs clearance service providers, and tariff guarantee services for temporary imports. Accredited participants are required to fill in the information regarding the temporary imported supplies and equipment on the “Chengdu 2025” App no later than one month before the official AND services period starts. For the specific procedures, please refer to the Customs Clearance Service Guide issued earlier by Chengdu ExCo, which can be accessed at: <https://www.theworldgames2025.com/activity/fisu?lang=zh&cid=delegation>. For media carrying the reporting and photographic equipment as carry-on luggage when entering China, ATA Carnet is recommended for the customs clearance.

8 TWG Village

8.1 Overview

8.1.1 Introduction to TWG Village

TWG Village consists of Zone A and Zone B, with Zone A at the Tianfu International Hotel Complex in Chengdu Eastern New Area and Zone B at the Holiday Inn Chengdu Century City in Chengdu Hi-tech Zone.

8.1.1.1 TWG Village Zone A

TWG Village Zone A contains 16 residential buildings, 2 athlete dining halls, and various supporting facilities.

9.5 Attaché Teams

During TWG 2025 Chengdu, the Participant Services Team will provide an Attaché team for IFs, offering support services for administration, liaison and communication, and language services, etc. The Attaché team is composed of liaison officers and Attachés. Each of the 34 sports is provided with one liaison officer; attachés are allocated according to the actual accredited size of each IF (Table 30). For team sports, one additional attaché will be added.

The Participant Services Team will coordinate with IFs to confirm the activation time of these Attachés. While Attachés receive assignments from Competition Managers, the Participant Services Team takes precedence over their deployment. Attachés assist participants with accreditation, check-in/check-out procedures, and attendance at official events, including Opening and Closing Ceremonies and Athletes' Night. They also handle other sport related tasks arranged by Competition Managers and provide non-official language services when necessary.

Please note the following points:

1. During TWG 2025 Chengdu, the Attaché team operates from 07:00 to 22:00 on a daily basis from 3 to 18 August 2025. Team members work a maximum of eight hours a day (including meal and rest breaks). No overnight shifts are required. Team members are entitled to one day of rest after five consecutive working days.
2. The Attaché team is only responsible for sport-related work. Attachés shall not be assigned tasks involving personal services such as shopping and dining, heavy physical labour or any duties that may compromise their health and safety.
3. Chengdu ExCo will provide catering and transport services for the Attaché team.
4. The Attaché team has access to TWG Village, official hotels, and competition venues. Their access to TWG 2025 Chengdu official venues is only limited to performing duties or participating in official activities. Their access to Federation Seats and competition venues is only limited to the public circulation area and the staff timeout area. They have no access to the participant dining area, hotel guest rooms, FOP, spectator area, anti-doping area, and guest timeout/lounge area.

10 Catering

10.1 Overview

Complimentary buffet services will be provided for athletes and officials in TWG Village Zone A and Zone B.

Complementary drinking water and refreshments services will be provided for athletes and officials at competition venues. Complementary drinking water will be provided during training.

Complementary drinking water and meal bags will be provided for athletes and officials participating in the opening and closing ceremonies.

10.2 Athlete Dining Halls in TWG Village Zone A and Zone B

For sports requiring provision of meals for their athletes before 06:00 or after 23:00 due to time constraints to meet competition schedules, competition managers or representatives of relevant sports may book such a service 24 hours in advance at the Athlete Dining Hall service counter, specifying headcount and timing. Meals will be provided accordingly.

10.2.2 Proposed Menu

Both Chinese and Western cuisines are available, with the main dishes rotating on a five-day cycle. The menu features a variety of hot and cold dishes, room temperature food, and hot and cold drinks.

10.2.3 Dish Label

All dishes are labelled in both Chinese and English, including details such as dish names, dietary attributes (e.g., gluten-free), ingredient compositions, nutritional information per 100 grams, and potential allergen information.

10.2.4 Special Services

Meal takeaway services are available for athletes who are unable to visit the Athlete Dining Halls due to injuries or medical conditions. Their teammates or other colleagues can pick up their meals at the service counter with a medical certificate, upon signing a food safety commitment form.

Athletes celebrating birthdays will receive birthday noodles (a Chinese cultural tradition) and birthday cakes without cream at the Athlete Dining Halls. Reservations must be made at the service counter 24 hours in advance.

10.2.5 Dining Notices

Only diners with knife and fork dining privileges () on their ID cards have access to the Athlete Dining Halls during opening hours.

Outside food and beverages are not allowed to be brought into the Athlete Dining Halls.

10.3 Competition Venues

10.3.1 Refreshments and Drinking Water Services

During competition days, athletes and officials will be offered refreshments and drinking water in designated TimeOut areas, available from one hour before the competition until its conclusion. During training days, drinking water will be provided in the TimeOut areas for the training sessions.

10.3.2 Special Meal Services

For participants unable to return to TWG Village for meals due to the time constraint to meet competition schedules, instant noodles and shelf-stable RTE meat will be provided for them alongside regular refreshments.

10.4 Opening and Closing Ceremonies Venues

Meal bags and drinking water will be provided for athletes and officials attending the opening and closing ceremonies.

11 Transportation Services

11.1 Transportation Services Period

Transportation services will be provided from the opening day to the closing day of TWG Village (3-18 August 2025).

11.2 Transportation Services Content

The transportation services include arrival and departure transportation services, Opening and Closing Ceremonies transportation, Competition and Training transportation, TWG Plaza Activities transportation and other transportation services. Refer to Bulletin #4 for detailed information.

11.2.1 Arrival and Departure Transportation Services

For Arrival and Departure, 24-hour shuttle services will be provided between the Official Points of Arrival and Departure (Chengdu Tianfu International Airport, Chengdu Shuangliu International Airport, and Chengdudong Railway Station) and TWG Village Zone A and Zone B, and coaches (in principle) will be used.

11.2.2 Opening and Closing Ceremonies Transportation Services

Shuttle services in accordance with schedules decided by the Opening/Closing Ceremony Operations Centre will be provided between TWG Village and the Opening/Closing Ceremonies venues, and coaches will be used.

11.2.3 Competition and Training Transportation Services

Competition and Training transportation services are divided into TA (Athlete Transport) and TO (Technical Official Transport). TA and TO-dedicated pick-up points will be set up in designated areas near TWG Village Zone A and Zone B to provide scheduled shuttle services between TWG Village and competition venues. For TA, the first bus will arrive at the competition venue 2 hours before the start of the first competition session on that day; for TO, the first bus will arrive at the competition venue 1.5-2 hours before the start of the first competition session on that day. The last bus will depart two hours after all competitions in the venue end on that day to return to TWG Village. For other periods, scheduled shuttle services will be available based on the competition and training schedules.

11.2.4 TWG Plaza Activities Transportation Services

Scheduled shuttle services will be provided between TWG Village Zone A and Zone B and TWG Plaza for participants to take part in TWG Plaza and Athletes' Night activities, and coaches will be used.

11.2.5 Other Transportation Services

1. Scheduled shuttle services between TWG Village Zone A and Zone B. This will generally run daily from 06:00 to 22:00, with a frequency of every 30 minutes during peak hours and every hour during off-peak hours. The schedule is adjustable according to actual needs, and coaches will be used.

2. Shuttle services between Fairmont Chengdu, Luxury Blue Horizon Hotel Chengdu and TWG Village Zone B. It will operate daily from 06:00 to 22:00, with a frequency of every 10 minutes. Public buses will be used.

3. Shuttle services between TWG Village Zone A and Tianfu International Airport North Metro Station will generally run daily from 07:00 to 23:00, with a frequency of every 20 minutes. Public buses will be used.

4. Special transportation services for sports equipment. Dedicated vehicles will be provided to meet relevant requirements.

5. Information on car/minibus rental service providers. Accredited participants, when needed, can rent vehicles at their own expense.

6. Free public transportation services, covering regular public buses and the metro system.

12 Medical Services

Comprehensive medical services, including venue medical services, emergency transfer, and inpatient treatment at designated hospitals, will be provided to all accredited persons during TWG 2025 Chengdu. Medical Emergency Service: 120

12.1 Venue Medical Services

12.1.1 Competition Venues

- Venue Medical Rooms, FOP First Aid Points, and Spectator First Aid Points for on-site medical services;
- Ambulances available for emergency transfer services;
- These facilities open one hour before competitions and close one hour after events conclude or upon the departure of the last athlete.

12.1.2 Non-competition Venues

- Venue Medical Rooms for on-site medical services;
- Ambulances available for emergency transfer services;
- Opening hours: 09:00-12:00 and 13:00-18:00 for routine medical services, and 24 hours for emergency and emergency transfer services.

12.1.3 Opening and Closing Ceremonies Venues

- Medical Rooms, and Tribune First Aid Points for on-site medical services;
- Ambulances available for emergency transfer services.

12.2 Treatment Process

Upon receiving a notification from the referee or related personnel, the medical staff at the venue will respond immediately to the scene. After the initial assessment and treatment by the on-site medical personnel, if it is deemed necessary, the individual will be transferred to a designated hospital for further treatment.

12.3 Designated Hospitals

The hospitals for TWG 2025 Chengdu include nearby and referral hospitals. All of them have green channels and reserved beds to provide medical services for accredited persons.

- Nearby Hospital: The large general hospital(s) geographically closest to the venue, used for emergency/urgent situations. Patients may be transferred to a referral hospital if deemed necessary by a doctor.
- Referral Hospital: Large hospitals with specialised critical care capabilities, providing 24-hour services.

12.4 Emergency Medical Services

Ambulances equipped with first-aid facilities and staffed by on-site doctors and nurses will be stationed at designated locations within venues to provide emergency transfer services at venues and TWG Village, and during major events such as the Opening and Closing Ceremonies.

In the event of an accident or sudden illness requiring urgent medical assistance during TWG 2025 Chengdu, immediately call China's emergency help line "120". Inform the dispatcher of your accreditation category/status, precise location, and medical condition. Professional rescue personnel will respond promptly.

12.5 Medical Consent

During TWG 2025 Chengdu, all athletes seeking medical treatment with or without medications, must complete and sign the *Informed Consent for Medical Intervention during The World Games 2025 Chengdu* (Table 33). Athletes may refuse any medical intervention.

According to Anti-Doping regulations, all athletes who use medications must strictly comply with the *Catalogues of Medications Used During The World Games 2025 Chengdu*. See the Medicine List of The World Games 2025 Chengdu (Table 34). Medications designated for staff use are prohibited for athletes except in emergencies, to ensure compliance with treatment and medication safety protocols. In line with Therapeutic Use Exemption rules, if the use of any prohibited medications or methods is required during competition periods, the attending physician, athlete or NOC team physician must complete the *Informed Consent for Using Medications Containing Prohibited Substances during The World Games 2025 Chengdu* (Table 35).

12.6 Medical Expenses

Chengdu ExCo will cover the costs of on-site treatment and emergency transfer services within Chinese Mainland for all accredited participants during TWG 2025 Chengdu. Costs incurred outside this period or geographical scope are not covered.

12.7 Public Health

Comprehensive public health security services for all personnel associated with TWG 2025 Chengdu will be provided during the entire event.

12.7.1 Pathogen Testing

Pathogen testing services will be provided for participants showing symptoms of transmissible/infectious disease to ensure prompt diagnosis and targeted treatment.

12.7.2 Smoking Control

TWG 2025 Chengdu will work hard to create a smoke-free environment. Smoking is prohibited in indoor areas (including public transport means) and outdoor areas where crowds gather for sporting events.

12.8 International Federation of Sports Chiropractic (FICS)

Fédération Internationale de Chiropratique du Sport, known as (FICS) is a not-for-profit volunteer organisation representing national sports chiropractic associations and the chiropractic profession internationally. FICS Vision is every athlete deserves access to sports chiropractic. As the leaders in Sports Chiropractic, they strive to provide equitable access to sports chiropractic care, education, mentoring, and research to all athletes and sports chiropractors regionally, nationally, and internationally. FICS maintains relationships with International Sporting Federations, Educational Institutions with a chiropractic program, and over 30 National Chiropractic Sports Councils (NCSC) across the globe.

FICS has several long-standing contracts and agreements to provide qualified Sports Chiropractic support to The World Games (TWG) and the CSIT World Workers Games and over 16 International Sporting Federations events. FICS supplied Sports Chiropractic services to all accredited members and athletes of The World Games since the 2005 Games in Duisburg, Germany. Each edition of TWG has demonstrated increasing utilization of the FICS service by the athletes and accredited individuals during the games. At TWG 2022 in Birmingham, Alabama over 3400 treatments were provided by FICS and over 26% of the athletes present at the games requested our care.

FICS will have members located at most warmup areas in the venues during the training and competitions. The focus of our care is to assist the athletes to be at their best, physically prepared for competition, and assist in recovery during and after their competition. Our delegation will be present throughout the games, and you are welcome to request our services at any venue. We are available as complementary service for any accredited individual. We will work in collaboration with the IWGA medical commission and medical services. We will also collect data on the treatments we provide during the games and report to the IWGA to further understand how we can support athletes and TWG.

13 Doping Control

13.1 Overview

To promote health, fairness and equality, athletes will be subject to doping control and can be tested (including urine and blood testing) anytime anywhere during TWG 2025 Chengdu.

13.2 Testing Requirements

Upon receiving a formal notice for a doping control test from authorised personnel, athletes should actively cooperate. Evasion, refusal or failure to complete the sample collection will be considered a violation of doping regulations.

13.3 Policy and Regulations

Athletes and support personnel shall understand and abide by all applicable anti-doping policies and rules of the *World Anti-Doping Code and 2025 IWGA Anti-Doping Rules*. All doping control activities will be carried out in strict accordance with relevant rules of the IWGA, ITA and WADA.

14 Sports Programme and Competition Venues

14.1 Overview

TWG 2025 Chengdu features 34 Sports, 60 disciplines, and 256 events. Spanning 11 days, TWG 2025 Chengdu will be held across 27 competition venues in 8 venue clusters. There are 12 indoor venues and 15 outdoor venues.

Programme: Leveraging outdoor landmark architecture and integrating the surrounding natural ecological landscape, the closing ceremony fully embodies the harmonious coexistence of sportsmanship and the pulse of the city. It will provide athletes from various countries and regions with a stage to “showcase themselves and perform to their fullest”. Athletes from all corners of the globe will gather here to cherish beautiful memories and share friendships.

17 Athletes’ Night

Athletes’ Night is another important official event during TWG 2025 Chengdu in addition to the Opening and Closing Ceremonies. It will feature two main themes: Park Excursion and Themed Carnival.

Before TWG 2025 Chengdu, IFs, NOCs/NSOs shall send photos of the front, back, and each side (sleeves) of the competition uniforms of the athletes and team officials to the Division of IPR Protection and Sports Industry Development, Department of Media (Opening and Closing Ceremonies), Chengdu ExCo (yangyang@theworldgames2025.com; xuerui@theworldgames2025.com). The photos should be in JPEG format, with a maximum resolution and size of 300dpi/500KB. Please try to compress them into a ZIP file. Before and during TWG 2025 Chengdu, Chengdu ExCo will conduct inspections of the clothing and items in venues and TWG Village to ensure compliance with the brand control standards.

18.1.2 Sponsors

The Marketing Sponsorship Programme for TWG 2025 Chengdu divides official sponsorships into: Global Partners, Official Partners, Official Sponsors, Official Exclusive Suppliers, Official Suppliers and Designated Sponsorship Category Products/Services/Platforms. Chengdu ExCo uses the support in cash and VIK (Value in Kind) from sponsors to provide financial, goods and services support for the preparations of TWG 2025 Chengdu.

18.2 Ticketing

Tickets for TWG 2025 Chengdu will be sold to the global audiences, and accredited participants may also purchase tickets as regular members of the public. The global ticket booking period runs from 29 April to the end of June 2025, with official sales starting at the end of June. All ticket purchases will take place online, through the following channels:

1. Official Website of TWG 2025 Chengdu (www.theworldgames2025.com): After real-name registration, you can book and purchase tickets. A confirmation SMS or email will be sent upon successful purchase.
2. WeChat Official Account of Ticketing: Search for “TWG 2025 Chengdu Ticketing System” and follow the instructions to register with your real name to purchase tickets and receive confirmation information.
3. Alipay Mini Program: Search “TWG 2025 Chengdu Ticketing System” on Alipay, register with your real name to book and purchase tickets and receive confirmation information.
4. Chengdu 2025 App (available in Chinese and English): Download and install the app, register with your real name to purchase tickets and receive confirmation information.
5. IWGA Official Website (www.theworldgames.org): After real-name registration, you can book and purchase tickets. A confirmation SMS or email will be sent upon successful purchase.

Chengdu ExCo will set up ticketing information desks in Zone A and Zone B of TWG Village and at official hotels for inquiries, but tickets must still be purchased through the aforementioned online platforms.

18.3 Official Merchandise

For TWG 2025 Chengdu, merchandising refers to the marketing model wherein Chengdu ExCo authorises eligible enterprises to produce and sell products bearing TWG 2025 Chengdu official identifications such as the emblem, slogan, and mascot and charges royalty fees. The merchandising programme operates around the production and development of licensed products which serve as a medium to showcase the host city’s local culture and unique urban characteristics, while further conveying the sportsmanship and the concepts of TWG 2025 Chengdu.

19 Security

19.1 Security Policies

19.1.1 Security Policy and Procedures for Competition Venues

1. Security personnel will be deployed around each competition venue for regular patrol and traffic control.
2. Security control will be implemented on a 24/7 basis at all competition venues. All personnel and vehicles intending to enter the venues will be subject to access control and security screenings.

19.1.2 Security Policy and Procedures for TWG Village

1. Security control will be implemented on a 24/7 basis. All personnel and vehicles intending to enter TWG Village will be subject to access control and security screenings. Access to TWG Village will only be granted to those accredited participants with the right access entitlement, and after they have passed the accreditation check and security screening.
2. Security personnel will be deployed at TWG Village for regular patrol and traffic control.

19.1.3 Security Policy for the Main Media Centre (International Broadcast Centre)

Security control will be implemented on a 24/7 basis. All personnel and vehicles intending to enter the Main Media Centre (International Broadcast Centre) will be subject to access control and security screenings. Access to the Main Media Centre (International Broadcast Centre) will only be granted to those accredited participants with the right access entitlement, and after they have passed the accreditation check and security screening.

19.2 Security Screening Policies

The Opening and Closing Ceremonies venues, TWG Village, competition venues, and the MMC (IBC) will operate under a fully enclosed security control model. Once these sites complete security sweeps, all inbound personnel and vehicles, and items intended to be brought into the security perimeter must undergo security screenings to prevent prohibited or restricted items from being brought into these sites.

19.2.1 Procedures for Pedestrian Security Screening

Pedestrian security screening will be conducted by the relevant venue-specific security teams of Chengdu ExCo.

Walk-through X-ray machines, metal detectors, handheld metal scanners, and visual inspections will be employed for personal and item screenings.

19.2.2 Vehicle Security Screening Policy and Procedures

All vehicles intending to enter any venues of TWG 2025 Chengdu must undergo vehicle security screenings. Vehicles must conduct self-inspections beforehand and comply with the following requirements:

- a. All vehicles must stop at designated vehicle security screening lanes and switch off engines.
- b. All drivers and passengers must disembark and undergo pedestrian security screening.

19.3 Other Security Policies

19.3.1 Prohibited and Restricted Items in TWG Village and MMC (IBC)

- a. Firearms, ammunition and explosives;
- b. Controlled apparatuses such as imitation guns, crossbows, and daggers;
- c. Flammables and explosives such as fireworks, crackers, gasoline, and ethanol;
- d. Highly toxic and corrosive hazardous chemicals and radioactive substances;
- e. Hazardous substances such as hazardous biologicals and pathogens of infectious diseases;
- f. All types of narcotic drugs such as heroin, cocaine, marijuana, and methamphetamine;
- g. Bows, balls, rackets, clubs, sticks, frisbees and other similar items, unless intended for training and competition purposes or carried by athletes participating in the sport;
- h. Electric scooters, bicycles, skateboards, roller skates and other means of transportation (except wheelchairs, mobility aids and vehicles permitted by Chengdu ExCo);
- i. Animals (except for service animals such as guide dogs, drug-sniffing dogs, and bomb-sniffing dogs);
- j. For items promoted and sold for commercial purposes by non-official sponsors and non-partners, refer to the Notice on Protecting Intellectual Property Rights of TWG 2025 Chengdu issued by Department of Media (Opening and Closing Ceremonies).
- k. Flags of non-participating countries or regions of TWG 2025 Chengdu; flags with an unfolded area of more than 2m*1m; flagpoles with a length of more than 1m;
- l. Banners and slogans bearing statements related to politics, race, religion and commerce, or violating the laws and regulations of China, and any items or clothing for publicity;
- m. Unauthorised wireless electronic equipment and other items that interfere with broadcast signals;
- n. Low-altitude, low-speed, small aircraft such as manned balloons, UAVs, model aircraft, unmanned free balloons, tethered balloons and paramotors, as well as other flying objects and their key components such as flight control and blades;
- o. Any item that Chengdu ExCo considers to be destructive or dangerous to competitions or facilities, and has a negative impact on TWG 2025 Chengdu;
- p. Any other item explicitly prohibited by laws and regulations of China.

19.3.2 Prohibited and Restricted Items in Competition Venues

The items prohibited and restricted to be brought by accredited persons (including athletes, technical officials, media and other staff) into competition venues include the following items in addition to those for TWG Village:

- a. Igniters such as lighters and matches;
- b. Alcoholic beverages;

In addition to the items prohibited and restricted for accredited persons, the following items are also prohibited and restricted to be brought into competition venues by spectators:

- a. Fragile products and all kinds of containers, such as glass bottles/cups, vacuum cups, ice boxes, and feeding bottles;
- b. Easy-to-throw food that exceeds the reasonable amount used by the person (such as large amounts of fruit or eggs);
- c. Bags larger than 50cm*50cm*50cm;
- d. Any unauthorised professional camera equipment (except for small handheld camera equipment for household use) as well as tripods for camera and video camera;
- e. Items that can distract the attention of participating athletes, technical officials, coaches and other items that may interfere with sports events or other spectators, including but not limited to whistles, horns, laser pointers;
- f. Sound amplification equipment, remote control toys, wireless devices and other electronic devices that interfere with activities;
- g. Other items that may affect safety and violate Chinese laws or VOC regulations.

19.3.3 Miscellaneous

If any of the above items are necessary tools or equipment carried by medical staff, media personnel and technicians, they should be brought into the venue after obtaining approval from the competent department of the venue and completing security screening.

20 Urban Cultural Experience Activities

20.1 Operation Period

Urban cultural experience activities are scheduled to be staged from 3 to 18 August 2025 (excluding 7 and 17 August). For details about routes and shuttle timetables, please consult the Urban Cultural Experience Activities Service Desk or the “Chengdu 2025” App.

21 Information Technology

21.1 Chengdu 2025 App

21.1.1 Overview

Chengdu ExCo has developed the “Chengdu 2025” App, a one-stop service platform. The app is available in Chinese and English and downloadable from various app stores, including Huawei AppGallery, Xiaomi GetApps, vivo V-Appstore, OPPO Store, Tencent Appstore, Apple Store, Galaxy Store, and Google Play.

21.1.2 Login and Identity Verification

After installing the App, you can enter your mobile phone number or email address by following the instructions on the page to complete registration.

After signing into your account, on the main screen, you can tap “Me” at the bottom right, then select “Identity Verification” and choose one of the following valid identity documents: accreditation card, passport, resident identity card of the People’s Republic of China, Mainland Travel Permit for Hong Kong and Macao Residents, or Mainland Travel Permit for Taiwan Residents. Once your identity is verified, you will gain access to customised services based on your accreditation category.

21.1.3 Services Available

Chengdu 2025 App features the following services: News, Chengdu (Culture, Travel, Food, Sports), Encyclopedia (Emblem, Mascots), Sports, Transportation Services, Urban Activity Booking, and Weather Services to keep users stay connected. It also serves as an information channel for the general public to know, participate in, and enjoy TWG 2025 Chengdu.

21.2 Internet Services

21.2.1 Wired Internet Access in TWG Village

Chengdu ExCo provides wired Internet access in TWG Village. Wired Internet access only covers some rooms, where participants can access the Internet free of charge. To access the Internet, participants must complete identity verification with usernames and passwords issued by Chengdu ExCo based on their accreditation information. A maximum of three wired or wireless connections are allowed for each account at a time.

How to log in:

Step 1: Connect the Ethernet cable to your device, which will automatically obtain an IP address.

Step 2: A Web authentication page pops up. Enter your username and password and check the user protocol. You will gain access to the Internet once your identity is verified. ¹

21.2.2 Wi-Fi Network Services in TWG Village

Wi-Fi coverage and Wi-Fi services are provided by Chengdu ExCo for all accredited participants in TWG Village. To access the Internet, participants must complete identity verification with usernames and passwords issued by Chengdu ExCo based on their accreditation information. Devices supported include PCs, mobile phones and tablets. A maximum three of wired or wireless connections are allowed for each account at a time.

How to log in:

Step 1: Within the Wi-Fi coverage in TWG Village, find the SSID of the Wi-Fi network. The bandwidth for participant groups (such as IFs, NOCs/NSOs, technical officials, athletes, team officials, competition managers, media, and staff) is determined by their accounts.

Step 2: After your device is connected, a Web authentication page pops up. Enter your username and password and check the user protocol. You will gain access to the Internet once your identity is verified. ²

21.2.3 Wired Internet Access Services in Venues

Wired Internet access services are open to the following participant groups: IFs, NOCs, NSOs, technical officials, athletes, team officials, competition managers, media, staff, and TWG 2025 Chengdu organisations. To access the Internet, participants must complete identity verification with usernames and passwords issued by Chengdu ExCo based on their accreditation information. A maximum three of wired or wireless connections are allowed for each account.

How to log in:

Step 1: Connect the Ethernet cable to your device, which will automatically obtain an IP.

Step 2: A Web authentication page pops up. Enter your username and password and check the user protocol. You will gain access to the Internet once your identity is verified. ³

21.2.4 Wi-Fi Network Services in Venues

Wi-Fi coverage and Wi-Fi services are provided in venues by Chengdu ExCo for the following participant groups: IFs, NOCs, NSOs, technical officials, athletes, team officials, competition managers, media, staff, and TWG 2025 Chengdu functional departments. Areas covered by the Wi-Fi network include competition and training areas, media areas, TWG TimeOut and other operational areas. To access the Internet, participants must complete identity verification with usernames and passwords

21.3 Telecommunication Services

21.3.1 Mobile Network Coverage in Chengdu

Mobile networks in use in the Chinese mainland include 5G (NR TDD), 4G (TD-LTE), and 4G (FDD-LTE). These networks provide comprehensive coverage throughout Chengdu. Reliable mobile telecommunication services are readily available for participants, including IFs, NOCs, NSOs, technical officials, athletes, team officials, and competition managers as long as they have mobile devices compatible with the above-mentioned networks and valid UIM or SIM cards.

21.3.2 Mobile Roaming Services

Participants with mobile phones compatible with the above-mentioned mobile networks can access China's mobile roaming services, including IFs, NOCs, NSOs, technical officials, athletes, team officials, competition managers, media, and staff. To use these services, participants must enable the international roaming service with their home country carriers.

21.4 Radio Management

21.4.1 Radio Frequency Application and License

All the radio transmitting equipment to be used during TWG 2025 Chengdu must comply with the *Regulations of the People's Republic of China on the Management of Radio Operation* and other relevant regulations. Domestic and overseas users who need to set up and use radio stations and radio transmitting equipment in venues and special control areas should first obtain information about frequency declaration, customs clearance, and equipment inspection at the official website of TWG 2025 Chengdu (https://www.theworldgames2025.com/en/activity/news/newsDetail?id=19273&lang=en&cid=column_170443775924395&locale=en). The applications are submitted via the official TWG 2025 Chengdu email address (FrequencyApplication@theworldgames2025.com). When their applications are approved, they will obtain a digital copy of the Frequency License.

Note 4: After a successful first-time login, you can access the Wi-Fi network in any competition venue/training venue with the same device without repeating the authentication process.

21.4.2 Application Period

The first application period is from 1 March to 30 April 2025. The second application period is from 22 May to 26 July 2025 (The application channel is only open to emergency requests for important frequency use during TWG 2025 Chengdu).

21.4.3 Equipment Entry

Overseas users who need to bring radio transmitting equipment into China shall present a printed copy of the *Frequency License to the Customs of the People's Republic of China* when going through the temporary entry formalities for such equipment.

21.4.4 Equipment Inspection

Licensed users shall bring the radio stations and radio transmitting equipment to the designated location for frequency transmission parameter inspection before use. The qualified equipment will be affixed with a special tag. For equipment inconvenient to move around, the user can contact the radio regulatory authority for on-site inspection and tagging.

21.4.5 Time and Locations for Equipment Inspection

Four radio transmitting equipment inspection points are set up during TWG 2025 Chengdu.

- Financial City Inspection Point: Building 9, Tianfu International Financial Centre, No. 966, Tianfu Avenue North Section, Hi-tech Zone, Chengdu. This point operates from 18 April to 17 August 2025.
- TWG Village Zone A Inspection Point: 1st Floor, Building C, Operation Centre, TWG Village Zone A. This point operates from 18 June to 17 August 2025.
- TWG Village Zone B Inspection Point: 2nd Floor, West Tower, TWG Village Zone B. This point operates from 18 June to 17 August 2025.
- Main Media Centre Inspection Point: 2nd Floor, Conference Centre, Western Financial Innovation Centre. This point operates from 18 July to 17 August 2025.

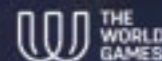
